The Executive Director (ED) is employed by VWB Canada and acts as ED for VWB USA in order to provide seamless leadership to the umbrella brand, VWB North America. Reporting to the Boards of Directors of VWB Canada and VWB USA, the Executive Director (ED) will have overall strategic and operational responsibility for VWB staff and network responsibilities including raising institutional and private funds and providing oversight and guidance to global and national programs run by VWB.

Specifically, the ED will be responsible for ensuring that VWB financial, operations, fundraising, marketing, human resources, and infrastructure strategies are effectively implemented across all areas of the organization. The candidate will have considerable experience in leading organizational growth, financial management of international NGOs, and in public relations. The ideal candidate will have a comprehensive understanding of, and experience within, the development and humanitarian sectors and be able to confidently articulate the VWB role and mission in a compelling manner.
